VETO MESSAGE

**STATEMENT OF THE REASONS FOR THE VETO OF ITEM IN
AMENDED SUBSTITUTE HOUSE BILL 434**

November 25, 2025

Pursuant to Article II, Section 16, of the Ohio Constitution, which states that the Governor may disapprove any item in a bill making an appropriation of money, I hereby disapprove the following item contained in House Bill 434 and set forth below the reasons for so doing, as it is not in the public interest. The text I am disapproving is identified in this message by reference to the corresponding page and boxed text of the bill.

Victim of Crime Vehicle Fees


This item would permit victims of crime to be charged a fee to reclaim their private vehicles after they've been seized as evidence by law enforcement as part of an ongoing criminal investigation. Ohio citizens who have been the victim of a crime should not be subject to fees in these situations. Permitting this practice would revictimize crime victims by allowing them to be charged hundreds to thousands of dollars for towing and storage fees before they can retrieve their own private property, which is contrary to Ohio's overall work to support crime victims. Potential federal and state constitutional issues also exist with this item.

The General Assembly is trying to resolve an issue where towing companies are not being compensated for their services. This is a real problem. This amendment, however, allows the burden of compensation to be placed on a crime victim. I am committed to working with the General Assembly on this issue, while also maintaining the rights of crime victims.

Therefore, the veto of this item is in the public interest.
