Enacted

HB 450 HANDGUN PURCHASES (Goodwin) To permit a member of the armed services or the Ohio National Guard who is between the ages of 18 and 21 to purchase a handgun if the person has received firearms training, to clarify the residency criterion for the issuance of a concealed carry license for persons who are absent from, or who are present in, the state in compliance with military or naval orders, to grant certain veterans and their families who relocate to Ohio immediate eligibility for in-state tuition at state institutions of higher education, to modify the fee for a license or temporary emergency license to carry a concealed handgun, to provide upon request made 15 months or later after the bill's effective date for the inclusion of a symbol indicating an honorable discharge from the military upon a veteran's driver's license, commercial driver's license, or state identification card, and to grant paid leave to certain state employees so that they may participate in a funeral honors detail at the funeral of a veteran.
