You will work to ensure their voices are heard and to influence policies that affect their lives.

### Job Responsibilities:

- Monitor and analyze federal and state public policy: Track legislation, administrative actions, and hearings relevant to aging issues. Provide timely assessments and prepare clear, concise reports for o4a leadership and members.
- Develop and implement advocacy strategies: Work collaboratively with our Advocacy Committee, lobbyist, CEO, and board to develop and execute the o4a Policy Agenda. Coordinate advocacy efforts through strategies such as testimony, public statements, legislative meetings, social media, earned media outreach, and member mobilization.
- **Support member engagement and activities**: Help plan and coordinate special advocacy events, trainings, and meetings. Manage projects and collaborations. Build advocacy capacity of members and partners.
- **Communications and outreach**: Contribute to the development of advocacy materials, such as talking points, briefs, and documents, for engaging supporters, stakeholders, and policymakers. Enhance the o4a website and newsletter with relevant content. Conduct presentations for internal and external stakeholders.
- Collaboration and teamwork: Maintain a strong working relationship with o4a staff, members, and external partners. Participate in state and national advocacy coalitions and workgroups.
- Stay informed and innovative: Research new advocacy initiatives and best practices in other states. Identify emerging needs and trends within the o4a network and propose solutions.

#### Qualifications:

- Bachelor's degree preferred (Public Policy, Communications, Social Work, or related field preferred).
- Minimum 3 years of experience in government affairs, such as legislative roles, community organizing, or nonprofit advocacy, required.
- Experience in aging services, Area Agency on Aging, Medicaid, health and human services, or adjacent issues preferred.
- Demonstrated commitment to social justice and advocacy for vulnerable populations.
- Excellent computer skills (proficient in MS Office Suite).
- Exceptional communication skills, both written and verbal.
- Strong interpersonal skills and ability to work effectively in diverse environments.
- Meticulous attention to detail and excellent organizational skills.
- Ability to work cooperatively and independently, taking leadership as needed.
